Reference is baseby made to that certain Agreement for the Sale and Redevelopment of Land ("Agreement") entered into by the CITY OF CHICAGO ("City"), ETC PROPERTY MANAGEMENT ("Original Purchaser"), INTERNATIONAL UNION OF OPERATING ENGINEERS LOCAL 399 ("Union"), and EDUCATION TRUST FUND LOCAL 399 ("Trust") (collectively herein "Or ginal Parties") dated as of June 11, 2002 and recorded on June 14, 2002 as document 30,70,887, relative to that certain parcel of property as legally described in the Agreement and or Exhibit A attached hereto ("Property").

The Original Parties hereby amend the terms of the Agreement to provide that an additional party will be joined to the terms and obligations of the Agreement. The additional party to be hereby joined is INTERNATIONAL UNION OF OPERATING ENGINEERS LOCAL 399 BUILDING CORPORATION ("Building Corp") an Illinois corporation. Building Corp. is the party designated by the Purchaser (as defined in the Agreement) to take title to the Property, which conveyance is done with the knowledge and consent of the City. All of the Original Parties remain fully obligated under the terms of the Agreement, and Building Corp. hereby joins fully in and with the obligations of the Purchaser, the Union, and the Trust under the Agreement. The terms and conditions of the Agreement shall continue to run with the land, as will the terms and conditions of this Amendment.
