WITNESSETH:

WHEREAS, Developer made and entered into that certain Declaration Of Condominium Pursuant To The Condominium Property Act - Kinetic Lofts at Rainbo Village Condominiums dated as of August 31, 2007 and recorded with the Recorder of Deeds of Cook County, Illinois on September 11, 2007 as Document Number 0725415119 (the “Declaration”); and

WHEREAS, pursuant to Section 23 of the Declaration, the Developer has the right to change or modify the Declaration to correct clerical or typographical errors, omissions or ambiguities in the Declaration or any Exhibit thereof, and

WHEREAS, Exhibit C to the Declaration listing each Unit Owner’s undivided percentage interest in the Common Elements was incorrectly attached to the Declaration and Developer desires by this Amendment to correct such error and substitute the correct Exhibit C for the incorrect Exhibit C.

NOW, THEREFORE, the Declaration is hereby amended as follows:

1. The Declaration is hereby amended to delete Exhibit C in its entirety and to substitute in lieu thereof Exhibit C attached hereto.
2. Except as expressly amended hereby, the Declaration shall remain in full force and effect in accordance with its terms. This Amendment shall be effective from and after the recording hereof with the Recorder of Deeds of Cook County, Illinois.


