## GENERAL CONTRACTOR'S MECHANIC'S LIEN NOTICE AND CLAIM

The undersigned Claimant, Bar atunde A. 1. Owner now holds title to that certain real proper y in the County Cook, State of Illinois, to wit:

THE NORTH HALF OF LOT 45 AND ALL OF LOT 46 IN BLOCK 3 IN MIFFLIN'S SUBDIVISION OF BLOCKS 3 AND 4, IN THOMPSO'N AND HOLMES SUBDIVISION OF THE EAST 45 ACRES OF THE NORTH 60 ACRES OF THE SOUTHEAST QUARTER OF SECTION 17, TOWNSHIP 38 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

The Property is commonly known as 5916 S. Sangamon Street, Chicago Linois 60621-2116.

- On or about August 7, 2007, Owner verbally accepted Claimant's written construction proposal (attached as EXHIBIT A) and entered into an agreement (the "Contract") for the performance of certain work and the delivery of certain materials by Claimant (the "Work") for the sum of FIFTEEN THOUSAND EIGHT HUNDRED DOLLARS AND ZERO CENTS (\$15, 800 00) (the "Contract Sum").
- On or about August 7, 2007, with knowing permission of Owner, in good faith, and to his detriment, Claimant proceeded to employ workers to improve the Property in the manner that Owner agreed, without a fully executed written contract but a contract implied in law.
- On or about September 7, 2007, Claimant completed all of the Work under the terms of and in accordance with the Contract, in that Claimant supplied all labor and materials necessary for performance of its duties under the Contract for the improvements to the Property.
- 5. All of the labor and materials furnished and delivered by Claimant were furnished to and used in connection with the improvement of the Property and the last of such labor and materials was

furnished, delivered and performed, and the work contemplated under the Contract completed, on or about September 7, 2007.

- 6. Owner submitted the construction proposal of Claimant to Owner's insurance company for reimbursement of the construction cost and has received insurance proceeds amounting to \$14,279.00 (\$1,730.00 on August 8, 2007; \$2,380.00 on September 7, 2007; and \$10,169.00 on November 6, 2007).
- Owner has not made any payments to Claimant and therefore has not fulfilled his obligation to Claimant.
- 8. Attached hereto as EXHIBIT B is Claimant's sworn statement to Owner in compliance with Section 5 of the Illinois mechanics' Lien Act (745 ILCS 60/0.01 et. seq.).
- 9. There is now justly due and owing the Claimant after allowing the Owner all credits, deductions and offsets, the sum of \$15,800.00 plus interest at the rate specified in the Illinois Mechanics Lien Act, 10% paramum from the date the Contract Sum is due.
- 10. Claimant now cai'ns a lien on the above-described Property, and on all of the improvements thereon, against the Owner and all persons interested therein for \$15,800.00 plus interest at the rate specified in the Islingia Mechanics Lien Act, 10% per annum from the date the Contract Sum is due, as well as court costs and reasonable attorney fees.


