That other than the foregoing three (3) children, PEGGY ANN VULPITTA, nee ROLLINS, never had or adopted any other child.

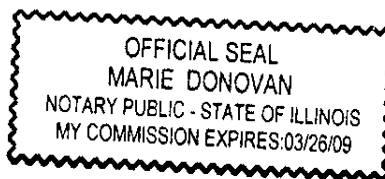

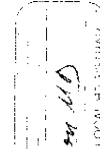
