SPECIAL WARRANTY DEED

Together with all and singular the hereditament and appurtenances thereunto belonging, or in anywise appertaining and the reversion and reversions, remainder and remainders, rents, issue and profits thereof and all the estate, right, title, interest, claim or demand whatsoever, unto the Grantee, either in law or in equity, of, in and to the above described premises, with the hereditament and appurtenances: TO HAVE AND TO HOLD the said premises as above described, with the appurtenances, unto the Grantee, her heirs and assigns forever.

Grantor also hereby grants to Grantee, her heirs and assigns, all rights and easements appurtenant to the above-described real estate, the rights and easements for the benefit of said real estate set forth in that certain Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for Condominium Association made the 18th day of May, 2005 and recorded on May 24, 2005 in the Office of Recorder of Deeds of Cook County, Illinois, as Document No. 0514403088 (the "Declaration"), and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining real estate described therein. This Deed is subject to all rights, easements, covenants, restrictions and reservations contained in said Declaration the same as though the provision of said Declaration were recited and stipulated at length herein. ~~Grantor further reserves to itself and its successors and assigns, and Grantee hereby grants to Grantor and its successors and assigns, the right to remedy as provided in the Purchase Agreement dated October 19, 2007 between 918 W. Ainslie, LLC, an Illinois Limited Liability Company and Christine Kohlhasc for the purchase of the real estate (the "Purchase Agreement") the terms of which are set forth in Exhibit A, attached hereto and made a part hereof. The foregoing right of remedy herein reserved by Grantor and granted by Grantee pursuant to the Purchase Agreement is hereby subordinated to the rights of the holder of any mortgage or trust deed hereafter placed upon the real estate described therein.~~

10. The Declaration of Condominium Ownership and of Easements, Restrictions, Covenants and By-Laws for Condominium Association of 918 West Ainslie Condominium Association;
11. Acts done or suffered by the Grantee or anyone claiming by, through or under the Grantee and
12. Grantee's mortgagee.
