Recorder of Cook County, IL as document number 0010899918 (the "Amendment"), but that Amendment was found, by court order, recorded as document no. 0426619081, to be null and void as an amendment to the Declaration.
- The legal description of the Units and Property now subject to the Declaration is attached C. hereto as Exhibit "A" and incorporated by reference herein; and
- The Board has now determined that the Plat attached as Exhibit "A" to the Declaration D. does not properly represent the reality of the improvements at the Property as it shows various garage-type buildings that no longer exist and it incorrectly shows the locations of various parking spaces (which are Limited Common Elements, "LCE")).
- In addition, the assignment of the parking space LCEs to the various units has been the E. subject of confusion, and the Unit Owners desire to resolve all such confusion and properly re-allocate the parking space LCEs


