hereby releasing and waiving all rights under and by virtue of the Homestead Exemption Laws of the State of Illinois. To
have and to hold the said premises with the appurtenances, upon the trusts and for the uses and purposes herein and in said
trust agreement set forth.

Full power authority is hereby granted to said trustee to improve, manage, protect and subdivide said premises or any party thereof, to dedicate

to grant options to purchase, to sell on any terms, to convey either with or without consideration, to convey said premises or any part thereof to a
successor or successors in trust and to grant to such successors or successors in trust of the title, estate, power and authorities vested in said trust, to
donate, to dedicate, to mortgage, pledge or other wise encumber said property, or any part thereof, to lease said property, or any part thereof, from
time to time in possession of reversion , by lease to commence in praesenti or futuro, and upon any terms and for any period and upon any term and
for any period or periods of time , not exceeding the case of any single demise the term of 198 years, and to renew or extend leases upon any terms
and for any period or periods of time and to amend, change or modify leases and the terms and provisions thereof of any time or times hereafter , to
contract to make leases and to grant options to lease and option to renew leases and options to purchase the whole or any part of the reversion and to
contract respecting the manner of fixing the amount of present or future rentals, to partition or to exchange said property, or any part thereof , for

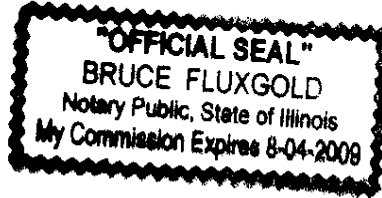

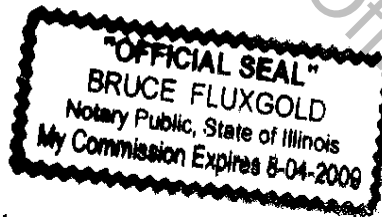
