LOAN MODIFICATION AGREEMENT

THIS MODIFICATION AGREEMENT made this 7th day of October 1998, by and between A. Theodore Kamberos and Nora Kamberos, husband and wife, and Marion Parry (hereinafter referred as "Borroyer") and North Community Bank, an Illinois Banking Corporation, with an office at 3639 North Broadway, Chicago, Illinois 60613 (hereinafter called "Mortgagee").

WINESSETH:

This Agreement is based upon the following recitals:

A. On September 6, 1991, for full value received, A. Theodore Kamberos, Nora Kamberos and Marion Parry, executed and delivered to Mortgagee a Note and Security Agreement in the principal amount of TWO HUNDRED FITTY THOUSAND FIVE HUNDRED AND 00/100 DOLLARS (\$ 250,000.00) (hereinafter called the "Note"), and secured the payment thereof by granting to Mortgagee, among other things, a certain Mortgage (hereinafter called the "Mortgage"), of even date with said Note, covering certain improved real property in the County of Cook, State of Illinois, which Mortgage was recorded on September 19, 1991, as Document No. 91486367 with the Recorder of Deeds of Cook County, Illinois, on property located at 217 West North Avenue, Chicago, Illinois 60610, covering the property described below (hereinafter called the "Mortgaged Premises"):

LOT 5 IN THE SUBDIVISION OF THE NORTH 103 FEET OF THE EAST 227.37 FEET OF A TRACT OF LAND KNOWN AS LOTS 118 AND 121 IN BRONSON'S ADDITION TO CHICAGO IN SECTION 4, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto do hereby mutually agree that the Note and Mortgage are hereby modif ed as follows:

- The Maturity Date of the Note will be extended from 1. September 6, 2001 to September 6, 2003.
- 2. Effective October 7, 1998, the inverest rate on the Note will be changed from a fixed interest rate of 8.75% to a fixed interest rate of 7.375%.
- All other terms and provisions of the Note and Mortgage will remain in 3. full force and effect.

In consideration of the modification of the terms of the Note by Lender, as hereinabove set forth, Borrower does hereby covenant and agree to pay the balance of the . indebtedness evidenced by the Note dated September 6, 1991 and secured by a mortgage of even date, recorded with the Cook County Recorder of Deeds on September 13, 1991 as Document No. 91486367 on property located at 217 West North Avenue, Chicago, Illinois 60610.

Nothing herein contained shall in any manner whatsoever impair the Note as modified hereby, or the lien created thereby or any other documents executed by Borrower in connection therewith, or alter, waive, vary or affect any promise, agreement, covenant or condition recited in any of the above-mentioned documents. Except as hereinabove otherwise provided, all terms and provisions of the Note, and other instruments and documents executed in connection with the subject loan, shall remain in full force and effect and shall be binding upon the parties hereto, their successors and assigns.
