I, Yusuf Muhammad Authorized Agent for Yusuf A Muhammad, as Maker, acting in accord with current Public Policy at House Joint Resolution 192 passed by the 73<sup>rd</sup> Congress of the United States, 1<sup>st</sup> Session on June 5, 1933 at 4:40 p.m., as codified, hereinafter referred to as "HJR-192," said resolution having never heen repealed and still being in full force and effect, and further in accordance with law as uniformly codified at CNIFORM COMMERCIAL CODES, Article 1 Part 1 § 1-103 and 1-104 and Part 2 § 1-20, Article 3, Part 1, Section 3-104, Article 3, Part 3 § 3-310, Article 3, Part 3 § 3-311 and Article 3, Part 6, § 603 and Illinois Code Title (765ILCS905/1) (FROM Ch. 95, par.51); (765 ILCS 905/2) (from Ch. 95, par. 52); (765 ILCS 905/3) (from Cl. 95, par. 53); (756 ILCS 905/4) (from Ch. 95, par.54); (765 ILCS 905/05 (from CH. 95, par. 55); (765 ILCS 905/13) (from Ch. 95, par. 63); Mortgage Act and all related code sections of the Illinois code; concerning the discharge of debts, acting in Mortgage Loan Account Number 608006, in the amount of \$25,000, in full compliance and full satisfaction of House Mortgage, Loan Account Number 608006.

This BONDED PROMISSORY NOTE is issued in good faith, with clean hands and at arm's length, and is not a dishonor of House Mortgage, Loan Account Number 608006. THIS IS A LAMFOR RECOUPMENT!

I, Yusuf A. Muhammad, Agent of Yusuf A Muhammad, hereby nominate and do appoint Insource Financial Services LLC of Huntington, NY to fulfill the position of Fiduciary Trustee of this BONDED PROMISSORY NOTE, TRACKING NUMBER RR481901198US, the same to be effective immediately as of the date set forth below, and to continue thereafter until notice is given by the Make or reappointment, substitution or cancellation. Said Bonded Promissory note is to be offset upon contract trust account 608006.

The duties and responsibilities of the Fiduciary Trustee shall be to present this BONDED PROMISSORY NOTE, TRACKING NUMBER RR481901198US to discharge, settle and close Mortgage Loan Account Number 608006, to adjust all records of accounting to show irrevocably that said loan is fully discharged, to issue the appropriate IRS 1099 forms and to be in compliance with all revenue requirements in this matter timely, to reconvey title to Mortgagor, Yusuf A. Muhammad, and to do all other acts requisite to fully, faithfully and specially execute said appointment.

The Fiduciary Trustee and Holder of House Mortgage, Loan Account Number 608006, is given ten (10) days from the date of service of this BONDED PROMISSORY NOTE, TRACKING NUMBER RR481901198US, together with this Verified Notice of Tender of Payment to protect the mode of Maker's tender of offer of performance to discharge and extinguish House Mortgage, Loan Account Number 608006, or to serve notice upon Make that the debt has been discharged and extinguished and that all obligations relating thereto have been satisfied.

Your bank failed to secure the original promissory note in commerce leaving it open to fraud. Further, The mortgage note, by using wording such as waiver of rights is a violation of UCC codes, I can not be forced to a waiver of my rights in a fraudulent contract. I actually provided full consideration. The bank did not lend me any funds. (false and misleading advertising) further I was not informed of my right to rescind the contract, nor was it disclosed that By recording the Mortgage documents, without the promissory note, legal evidence of consideration is missing. Since this fraud has been discovered, and there was not consideration for the mortgage, or application for loan, I am hereby rescinding my signature on those documents, along with any deed of trust or other instrument. Assuming Insource Financial LLC of Huntington, NY, operates as required under Generally accepted Accounting Practices, it will obviously appear as a liability to the bank books, and as such, please return the total of payments plus the promissory note to my attention.

Since the promissory note was deposited into a transaction account and another check issued to the former "alleged lender" it appears check kiting occurred. Said transaction amounts to unlawful conversion. This document is a formal request for both sides of the books, for examination by a forensic accountant. This process that opened the transaction has opened this to fraud, and has reduced the owners to the "alleged position" of tenant. The bank has never been in possession of the property. All attorney efforts to delay, in this attempt to remedy this situation shall be considered as conspirators operating in bad faith and shall be under contract for injury to Yusuf A. Muhammad for an amount equal to 800 times the amount for unlawful conversion. Further these attempts, if undertaken shall be considered fraud, racketeering, extortion etc. This document constitutes a complete confession of judgment, and a lawfully perfected lien, in the amount of the promissory notes, \$213,000 plus the sum of all payments, plus the sum of this bonded promissory note, \$313,113.60; all due and payable without further notice, and as a contractually agreed appointment of trustee, to any bankruptcy court within the United States, or by direct treasury liquidation.
