MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated November 8, 2007, is made and executed between BASHIR M. CHAUDRY A/K/A BASHIR M CHAUDHRY, whose address is 6655 N MONTICELLO AVE, LINCOLNWOOD, IL 60712 (referred to below as "Grantor") and Allegiance Community Bank, whose address is 8001 W. 183rd Street, Tinley Park, IL 60487 (referred to below as "Lender").

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms.
