### ORDER VESTING TITLE

This cause coming to be heard on Plaintiff, Village of Maywood's Petition For Immediate Vesting of Title in Plaintiff, to a certain parcel described in Plaintiff's Petition as 1421 St. Charles Road, Maywood, Illinois, and described in Petitioner's Complaint for Condemnation as Parcel 014, Plaintiff appearing, due notice given, and it appearing to this Court that on the 15<sup>th</sup> day of September 1998, this Court found, adjudged, and ordered the amount constituting just compensation for the taking of the aforescribed parcel to be \$ 80,000.00.

It further appearing to the Court that the Plaintiff on the 30<sup>th</sup> day of September 1998, deposited with the Treasurer of Cook County, Illinois, the total sum of \$ 80,000.00, the amount so found by this Court.

IT IS HEREBY ORDERED AND ADJUDGED that Plaintiff be vested with fee simple title to the following described property on the 5<sup>th</sup> day of November 1998:

Parcel 014

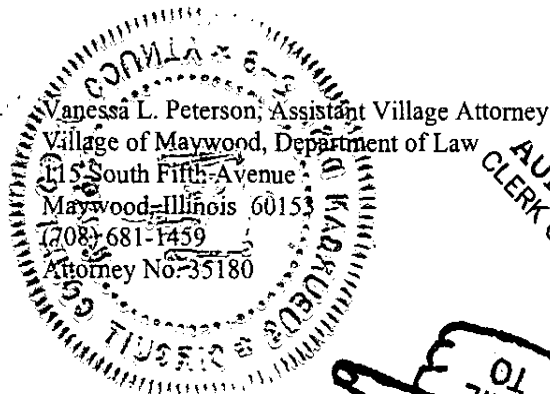

and identified by Permanent Tax Number (PIN) 15-10-225-014-0000;

IT IS HEREBY FURTHER ORDERED AND ADJUDGED, based on the parties' Settlement Agreement, that the Plaintiff is authorized to take possession of and use said property on the 10<sup>th</sup> day of November 1998.
