5. Property Insurance. Borrower shall keep the improvements no veristing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This in urance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the ir trace shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised un assembly. Lender may require Borrower to pay, in connection with this Loan, either: (a) a one-time charge for flood zone description, certification and tracking services; or (b) a one-time charge for flood zone determination and certification services and subsequent charges each time remappings or similar changes occur which reasonably might affect such determination or ce the cation. Unless an agreement is made in writing or Applicable Law requires interest to be paid on such insurance proceeds, Leager shall not be required to pay Borrower any interest or earnings on such proceeds. Fees for public adjusters, or other third parties, retained by Borrower shall not be paid out of the insurance proceeds and shall be the sole obligation of Borrower.
