THIS SUBORDINATION AGREEMENT, made in the City of Chicago, State of Illinois this 24TH day of AUGUST, 1998 by LaSalle Bank, a national banking association organized and existing under and by virtue of the laws of the United States of America, and doing business and State of Minois ("Bank").

That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated reflecting and securing the loan made by Mortgagee to Borrower, in the amount of ONE HUNDRED FORTY-FIVE THOUSAND DOLLARS AND NO/100, and to all renewals extensions of replacements of said Mortgagee's mortgage; and
  - 2. That this Agreement shall be binding upon and shall insure to the benefit of Mortgagee, its syccessors and assigns.
