SPECIAL WARRANTY DEED

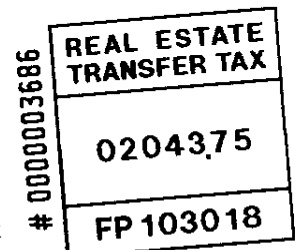
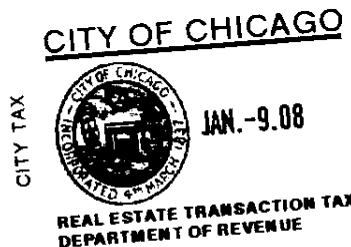
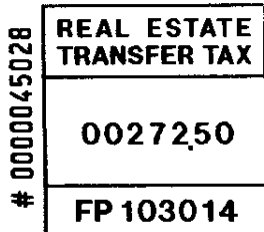
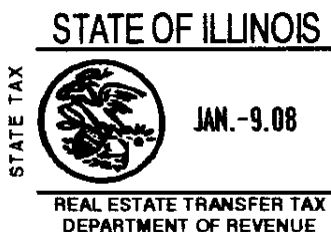
