NOTICE & CLAIM FOR LIEN IN THE AMOUNT OF \$6,000.00

NOTICE AND CLAIM FOR MECHANICS' LIEN

The undersigned Claimant, Robert Davis, doing business as, Davis Electric Co., in his behalf, claims a Mechanics' Lien on the tract of land described below, and improvements on the land under the Illinois Mechanics Lien Act, 770 ILCS 60/0.01 to 60/39, and states as follows:

1. At all times mentioned, Iftikhar Qureshi was the owner and tessee, of lots of land in the City of Chicago, County of Cook, Illinois, commonly known as 1906-1913 F. 79th Street, Chicago, IL, and described as follows:

On September 5, 2007, the undersigned Claimant made an express contract with the lessee, by which contract Claimant agreed to: replace defective lighting service, replace defective meter socket, replace defective distribution equipment and relocate service drop conductors out of normal reach, and for the improvement of, the premises, for the price of \$12,000.00 plus any extras which might be contracted for from time to time, which sum was to be payable upon completion of the work.
 - 3. Claimant has completed the furnishing and performance of all work, labor and

- 5. There is now due to Claimant for the furnishing, performance and delivery of the work, labor, services, material and fixtures, including extras, after allowing the owner all credits, deductions and setoffs, the sum of \$6,000.00, all of which is still unpaid.
- 6. The above-named claimant now claims a Mechanics' Lien on the above-described premises and all improvements on the premises against all persons interested in the premises, for the sum of \$6,000.00, together with interest, according to the statute.
