MEMORANDUM OF AMENDMENT TO SITE AGREEMENT

THIS MEMORANDUM OF AMENDMENT TO SITE AGREEMENT ("Amended Memorandum"), by and between Mulligat Holding, Inc., an Illinois corporation ("Owner") and SprintCom Inc., a Kansas corporation, ("Sprint PCS"), evidences that the lease made and entered into by written SITE AGREEMENT between Owner and Sprint PCS or Sprint PCS's affiliate, dated April 20, 2004 ("Agreement"), has been amended by written agreement between the parties (the "Amendment"). The parties caused to be recorded a Memorandum of Agreement with the Office of County Recorder, County of Cook, State of Illinois, as document number 0411739099 on April 26, 2004.

The Amendment provides in part that Owner leases to Sprint PCS certain real property owned by Owner and located at 3024 North Pulaski Road, City of Chicago, County of Cook, State of Illinois, together with non-exclusive utility and access easements (the "Site"). The Site which is the subject of the Agreement is described in Exhibit A attached hereto. The Amendment grants Sprint PCS the option to extend the Agreement for five (5) additional sixty (60) month terms after the expiration of the new initial sixty (60) month term which commenced on November 20, 2007.


