entered into an oral subcontract whereby PALIMBO was to provide bituminous asphalt paving and

related labor, materials and equipment for said project; PALUMBO thereafter completed all of its

obligations pursuant to said subcontract on or about Avgust 14, 1998.

To date, despite due demand for payment, Claimant remains unpaid for said work; and there

is no reasonable basis for the failure to pay PALUMBO.

Therefore, after all due credits, the amount left due, unpaid and owing to PALUMBO is

\$35,461.70, for which amount, plus interest and collection costs, including reasonable attorneys' fees,

PALUMBO claims a lien on the LAND and improvements thereon, and on any movies due or to

become due to PARK or any other party from OWNER for said project.
