MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated January 4, 2008, is made and executed between Cynthia Mitchell and Kenneth J. 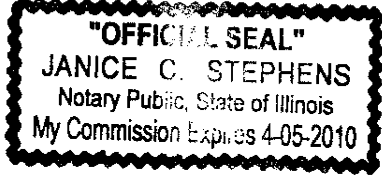

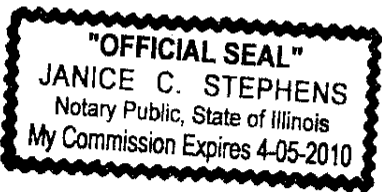
