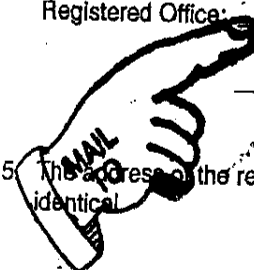

5. Any change of registered agent must be by resolution adopted by the board of directors. This statement must be signed by a duly authorized officer.
