Real Estate Subordination Agreement (Bank of America to Third Party)

This Real Estate Subordin ("Agreement") is executed as of **January 09, 2008**, by Bank of America, N.A., having an address of +7<sup>5</sup> Crosspoint Parkway, Getzville, New York 14068 ("Subordinator"), in favor of **ABN-AMRO Mortgage Group**, ("Junior Lien Holder"), having an address for notice purposes of **1201 East Lincoln Madison Hts. MI 480/1**.

Whereas, Subordinator is the owner and holder of, or creditor under, the indebtedness described in and secured by a security instrument (deed of trust, deed to secure debt or mortgage) dated October 03, 2007, executed by Joseph stewart and Melissa Stewart and which is recorded in Volume/Book N/A, Page N/A, and if applicable, Document Number 00728533079, of the land records of Cool, County, Illinois, as same may have been or is to be modified prior hereto or contemporaneously herewith (the "Se lior Lien"), encumbering the land described therein (said land and such improvements, appurtenances and other rights and interests regarding said land, if any, as are described in the Senior Lien being called herein collectively, the "Propert") and

Whereas, Junior Lien Holder has been requested to make a loan, line of credit or other financial accommodation to Joseph stewart and Melissa Stewart (jointly and severally, "Berrower"), to be secured by, without limitation, either a deed of trust, deed to secure debt or mortgage (the "Junior Lie."), covering without limitation, the Property and securing the indebtedness described therein including the payment of a pron issory note, line of credit agreement or other borrowing agreement made by Borrower and/or others payable to the order of ABN-AMRO Mortgage Group in the maximum principal face amount of \$416,000.00 (the "Principal Amount") [For North Carolina only – bearing interest and payable as therein provided at the maximum rate of n/a/ for a period not to exceed n/a months], including provisions for acceleration and payment of collection costs (the "Obligation"); the Junior Lien and the Obligation to contain such other terms and provisions as the Junior Lien Holder and Borrower shall determine; and

Now, Therefore, for valuable consideration, Subordinator hereby subordinates the Senior Lien of Junior Lien, subject to the terms of this Agreement. The Subordinator's Senior Lien is subordinated to the Junior Lien only to the extent of the Principal Amount of the Obligation and any amounts advanced pursuant to the terms of the Obligation or the security instrument for the payment of insurance premiums, taxes, costs of collection, protection of the value of the property or Junior Lien Holder's rights in the Property or foreclosure. All other rights of Subordinator now or hereafter existing in or with respect to the Property (including but not limited to all rights and to proceeds of insurance and condemnation) are hereby subordinated, and are and shall remain completely and unconditionally subordinate, to the Junior Lien and the rights of Junior Lien Holder regardless of the frequency or manner of renewal, extension, consolidation or modification of the Junior Lien or the Obligation.
