



# MEMORANDUM OF DEALER SUPPLY AGREEMENT FOR DEALER-OWNED, DEALER-OPERATED FACILITY Illinois

- 1. <u>Dealer Supply Agreement</u>. For valuable consideration, Dealer grants to BP a right of first refusal to purchase all of Dealer's interest, whether fee or leasehold, in the Real Estate commonly known as 6119 North Ave. in the City of Oak Park, County of Cook (the "County"), State of Illinois, with Tax Identification No. 16-05-104-031-0000 and more particularly described in the attached Exhibit A, and all improvements located at the real Estate. The unrecorded Dealer Supply Agreement between BP and Dealer dated on or about December 7, 2007, more fully sets for the terms of BP's right of first refusal. The term of the Dealer Supply Agreement is five (5) years, subject to four (4) five (5) year renewals set forth therein. The Dealer Supply Agreement is incorporated by reference into this Memorandum. If a provision in this Memorandum conflicts with a provision in the Dealer Supply Agreement regarding BP's right of first refusal, the provision in the Dealer Supply Agreement will control.
- 3. <u>Purpose of Memorandum; Conflicting Provisions</u>. The purpose of this Memorandum is to make BP's rights of first refusal a matter of public record.
- 4. <u>Expiration of the Agreement</u>. Upon the expiration of the Franchise Agreement, or the Dealer Supply Agreement, and BP's receipt of a written request from Dealer, BP shall record

a termination of the affected Agreement and this Memorandum in the Official Records of the County.
