**SPECIAL WARRANTY DEED**

**PARCEL 1:**

**UNIT NO. 5923-2N** in the **THORNDALE HARBOR CONDOMINIUM** as delineated on a survey of the following described property:

Lot 16 and the North 1/2 of Lot 15 in Block 19 in Cochran's Second Addition to Edgewater, a Subdivision of the East Fractional Half of Section 5, Township 40 North, Range 14 East of the Third Principal Meridian, Except the West 1320 Feet of the South 1313 Feet Thereof and the Right of Way of the Chicago, Evanston and Lake Superior Railroad, in Cook County, Illinois

Which survey is attached to the Declaration of Condominium recorded as Document No. 0612834012 together with an undivided percentage interest in the common elements.

**PARCEL 2:**

The exclusive right to use Balcony Rights **5-5923-2N**, Limited Common Element, as delineated on the survey attached to the Declaration aforesaid recorded as Document No. 0612834012.

Grantor also hereby grants to the Grantee, its successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the Declaration of Condominium, aforesaid, and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining property described therein.

This deed is subject to all rights, easements, covenants, conditions, restrictions and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

This deed is subject to:

1. Current non-delinquent real estate taxes and taxes for subsequent years;
2. The Declaration;
3. Public and utility easements;
4. Covenants, conditions, restrictions of record;
5. Applicable zoning and building laws, ordinances and restrictions;
6. The Condominium Property Act of Illinois;
7. Acts done or suffered by the Purchaser;
8. Purchaser's mortgage.

The subject building was completely vacant for over one hundred twenty (120) days prior to the recording of the aforesaid Declaration, and, therefore, no tenant right of first refusal existed.
