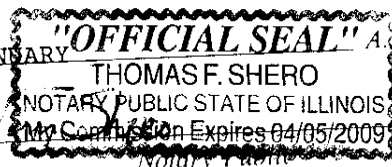

### Parcel 1:

Lot 15 (except the West 18 feet) and all of Lot 16 in Block 2 in Butler, Wright and Webster's Addition to Chicago in the West Half of the West Half of the Northeast Quarter of Section 9, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois

### Parcel 2:

Exclusive easement for the benefit of the following legal description:

Lot 15 (except the West 18 feet) and all of Lot 16 in Block 2 in Butler, Wright and Webster's Addition to Chicago in the West Half of the West Half of the Northeast Quarter of Section 9, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois as created by Grant of Easement made by and between the City of Chicago and American National Bank and Trust Company of Chicago, as trustee under Trust Number 105163 recorded September 18, 1990 as Document 00454674 for the construction, operation and maintenance of the proposed structure (a twelve-story office building) within the air space boundaries described as follows:
