MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated January 4, 2008, is made and executed between James J. Sayegh, whose address is 1943 W. Bradley Place, Chicago, IL 60613 (referred to below as "Grantor") and Devon Bank, whose address is 6445 N. Western Ave., Chicago, IL 60645 (referred to below as "Lender").

MORTGAGE. Lender and Grantor have entered into a Mortgage dated December 12, 2006 (the "Mortgage") which has been recorded in Cook County, State of Illinois, as follows:

REAL PROPERTY DESCRIPTION. The Mortgage covers the following described real property located in Cook County, State of Illinois:

Lot 15 in John Turner's Heir's subdivision of Blocks 1 to 4 inclusive of Turner's subdivision of the Southwest 1/4 of the Northeast 1/4 of Section 19, Township 40 North, Range 14, East of the Third Principal Meridian, West of Lincoln Avenue (except that part of the North 1/4 of the Northwest 1/4 of said Southwest 1/4 West of Wolcott Street) in Cook County, Illinois.

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:



If any person who signed the original Mortgage does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

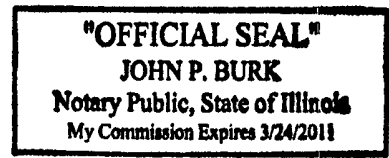

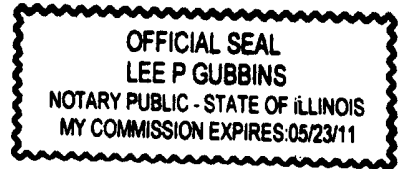
