SECOND AMENDMENT TO MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTS-FIXTURE FILING

THIS SECOND AMENDMENT TO MORTGAGE, SECURITY AGREEMENT AND ASSIGNMENT OF LEASES AND RENTS - FIXTURE FILING made this 6th day of November, 2007 by **GROVE ST. WHEREAS, Mortgagor and Mortgagee are parties to a Mortgage dated as of December 21, 2005 and recorded as Document No. 0536334074 and that certain First Amendment to Mortgage, Security Agreement and Assignment of Leases and Rents-Fixture Filing dated as of November 6, 2006 and recorded as Document No. ______ with the Cook County Recorder (the "Mortgage"), with respect to the real estate described on Exhibit A hereto (the "Property") securing, among other things, the indebtedness of Mortgagor, to Mortgagee under that certain Construction Loan Agreement dated as of December 21, 2005, as amended from time to time (as amended, the "Loan Agreement"); and

WHEREAS, the Mortgagor requested and the Mortgagee agreed pursuant to the terms of that certain Second Note Modification Agreement dated November 6, 2007 (the "Second Note Modification Agreement") to extend the maturity date of the Note to November 6, 2008; and

NOW, THEREFORE, in consideration of the foregoing premises, the mutual covenants herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. <u>Incorporation and Definitions</u>. The foregoing recitals and all Exhibits hereto are hereby made a part of this Agreement and incorporated herein. Capitalized terms used herein and not otherwise

defined shall have the meanings ascribed to them, respectively, in the Loan Agreement, the Note and the Mortgage.

- 2. <u>Note</u>. The maturity date under the Note is hereby extended to November 6, 2008. Mortgagor confirms and agrees that the Mortgage is and shall continue to be security for any and all indebtedness of Mortgagor to Mortgagee including but not limited to any and all amounts due under the Note, as it may be amended, extended, restated or modified from time to time.
- 3. <u>Additional Covenants of Mortgagor</u>. Mortgagor shall reimburse Mortgagee for all costs incident to recording this Agreement with the Recorder's Office of Cook County, Illinois.
- 4. <u>Pacifirmation of Mortgage</u>. All of the terms, conditions, agreements and provisions set forth in the Mortgage, as heretofore, hereby and hereafter amended, modified and supplemented, shall be and they hereby are reanirmed, ratified and confirmed in their entirety and incorporated herein by reference as if fully set forth herein and Mortgagor confirms and agrees that this Mortgage is and shall remain a first and prior lien on the Property and secure all indebtedness due Mortgagee under the terms of the Loan Agreement including but not minited to the indebtedness due under the terms of the Note. All references in the Mortgage to the Mortgage shall hereafter be deemed to refer to the Mortgage as amended by this Agreement. This Agreement shall be governed by and construed in accordance with the internal laws of the State of Illinois. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
- 5. Representations and Warrant.es. To induce Mortgagee to enter into this Agreement, Mortgagor represents and warrants that, as or the date of this Agreement, no Event of Default or event or condition which, with notice or the passage of time or both, would constitute an Event of Default, has occurred and is continuing under the Mortgage, and Mortgagor affirms the representations and warranties contained in the Mortgage shall be true and correct as of the date of this Agreement, except that they shall be deemed also to refer to this Agreement.
- 6. <u>Miscellaneous</u>. The title of this Agreement and the headings of the various paragraphs of this Agreement have been inserted only for the purposes of convenience and are not part of this Agreement and should not be deemed in any manner to modify, explain, expand or restrict any of the provisions of this Agreement. This Agreement may be executed in counterparts, each of which shall constitute an original, but all together shall constitute one and the same instrument.
