- 4. The Contract was entered into between "Becker" and "Forest Lumber" with the full knowledge and consent of the Owner(s). Alternatively, the Owner(s) specifically authorized "Becker" to enter into Contracts for the improvements at the premises. Alternatively the Owner(s) did knowingly permit "Becker" to enter into Contracts for the improvement at the premises.
- 5. At the special instance and request of "Becker" and with the full knowledge and express consent or acquiescence of Owner(s), Claimant furnished extra and additional materials and extra and additional labor on the Real Estate to the value of \$ 00. Claimant completed providing the additional materials and labor at various times.
- 6. On November 19, 2007 Claimant completed and delivered, substantially all work and materials required to be performed under the contract.
 - 7. That "Becker" is entitled to credits for payments in the amount of \$72,000.00.
- 8. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by "Becker" the balance of Eighteen Thousand, Seven-Hundred and Fifty-Four Dollars & 67/100, (\$18,754.67), for which with interest, Claimant claims a lien on the Real Estate and on the monies or other considerations due, or to become due from the Owner(s) to Becker Works Construction, Inc.
