MODIFICATION OF REVOLVING CREDIT LOAN AGREEMENT AND MORTGAGE

This Modification of Revolving Credit Loan Agreement and Mortgage (the "Modification") is made this 17th day of December 2007 by and between Willer Laude and Farah Laude, husband and wife, and Jeanette Laude, an unmarried woman (the Porrower") and NEW TRIER FEDERAL CREDIT UNION, incorporated by an Act of Congress (the "Lender"), with reference to the following facts:

By that certain Mortgage (the 'Mortgage") dated October 5, 2001 by and between Borrower and Α. Lender, as Mortgagee, recorded October 24, 2001, as Document No 0011000668, modified and recorded January 7, 2003 as Document No 0930026921 with the Recorder of Deeds of Cook County, Illinois, the Borrower mortgaged to Lender that certain real property located in Cook County, Illinois, legally described as follows:

The Mortgage secures the Revolving Credit Loan Agreement (the "Agreement") of even date establishing a line of credit in the amount of \$49,000.00 with a term of 60 months, the maturity date of which is December 1, 2007

- B. Borrower wishes to extend the term of the Agreement to a platurity date of December 1, 2012, and Lender Agrees to this modification with respect to the new term and maturity date.
- C. The Agreement and Mortgage are hereby modified and amended as follows:
 - 1. The grant set forth in the Mortgage is made for the purpose of securing, and shall secure payment of the Agreement with interest thereon, according to its terms, per the credit limit set forth in the Agreement, as well as payment by Borrower of all sums due and owing under and performance of all obligations set forth in the Agreement and this Modification, and satisfaction and performance by Borrower of each and every obligation of Ecrrower set forth in the Agreement, Mortgage or this Modification.
 - 2. The last full sentence in Covenant 23 (Future Advances) of the Mortgage is hereby amended to read: "However, no advances will be made beyond the 15th year of the term of this Mortgage."
 - 3. The Agreement is hereby modified as follows:
 - a. The section titled PRINCIPAL REDUCTION shall read "During the draw period the minimum payment of any not fully repay the principal that is outstanding on your line, depending on when you take your draws, even though the term of this loan is 180 months and the amortization is based on a 180 month payback."
 - b. The Maturity Date is amended to read **December 1**, 2012
 - c. The Draw Period is amended to read 15 years.
 - 4. All other terms, except as modified and amended by this Modification, are confirmed and ratified and all provisions thereof in the Agreement and Mortgage shall remain in full force and effect.
