This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. If Borrower abe dons the Property, Lender may file, negotiate and settle any available insurance claim and related nature. If Borrower does not respond within 30 days to a notice from Lender that the insurance carrier has offered to settle a claim, then Lender may negotiate and settle the claim. The 30-day period will begin when the notice is given. - 9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. If
 (a) Borrower fails to perform the covenants and agreements contained in this Security Instrument, (b) there
 is a legal proceeding that might significantly affect Lender's interest in the Property and/or rights under
 this Security Instrument (such as a proceeding in bankruptcy, probate, for condemnation or forfeiture, for
 enforcement of a lien which may attain priority over this Security Instrument or to enforce laws or
 regulations), or (c) Borrower has abandoned the Property, then Lender may do and pay for whatever is
