B. USE OF PROPERTY; COMPLIANCE WITH LAW. Borrower shall not seek, agree to or make a change in the use of the Property or its zoning classification, unless Lender has agreed in writing to the change. However, Borrower shall receive the Rents until (I) Lender has given Borrower notice of default pursuant to paragraph 21 of the Security Instrument and (ii) Lender has given notice to the tenant(s) that the Rents are to be paid to: Lender or Lender's agent. This assignment of rents constitutes an absolute assignment and not an assignment for additional security only.

Any application of Rents shall not cure or waive any default or invalidate any other right or remedy of Lender. This assignment of Rents of the Property shall term inate when all the sums secured by the Security Instrument are paid in full.

I. CROSS-DEFAULT PROVISION. Berro ver's default or breach under any note or agreement in which Lender has an interest shall be a breach under ne Security Instrument and Lender may invoke any of the remedies permitted by the Security Instrument.
