FOURTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND BY-LAWS, EASEMENTS, RESTRICTIONS AND COYENANTS FOR SHERIDAN PLACE IN UPTOWN CONDOMINIUM

(FOR RECORDER'S USE ONLY)

This Fourth Amendment to the Declaration of Condominium Ownership and By-Laws, Easements, Restrictions and Covenants for Sheridan Place in Uptown Condominium is made and entered into by the Sheridan Piece in Uptown, L.P., an Illinois limited partnership ("Declarant").

RECITALS

- By the Declaration of Condominium Ownership and By-Laws, Easements, Restrictions and Covenants for Sheridan Place in Uptown Condominium recorded in the Office of the Recorder of Deeds of Cook County, Ulinois ("Recorder's Office") as Document No. 0715515066 (the "Original Declaration"), as amended by that certain First Amendment to Declaration of Condominium Ownership and By-Laws, Ensements, Restrictions and Covenants for Sheridan Place in Uptown Condominium recorded in the Recorder's Office as Document No. 0726215000 (the "First Amendment"), that certain Second Amendment to Declaration of Condominium Ownership and By-Laws, Easements, Restrictions and Covenants for Sheridan No. 0715515066 (the "Original Declaration"), as amended by that certain First Amendment to Place in Uptown Condominium recorded in the Recorder's Office as Document No. 0729115218 (the "Second Amendment"), and that certain Third Amendment to Declaration of Condominium Ownership and By-Laws, Easements, Restrictions and Covenants for Sheridan Place in Uptown Condominium recorded in the Recorder's Office as Document No. 0803216005 (the "Third Amendment"; the Original Declaration, as amended by the First Amendment, the Second Amendment and the Third Amendment, are hereinafter referred to collectively as the "Declaration"), certain real estate comprising a portion of the real estate legally described on Exhibit A attached hereto and made a part hereof was submitted to the Illinois Condominium Property Act ("Act"), said condominium being known as Sheridan Place in Uptown Condominium ("Condominium");
 - Declarant reserved the right to annex certain Additional Property, as that term is defined in the Declaration, included within the real estate legally described on Exhibit A attached hereto, to the Condominium Property, as that term is defined in the Declaration, from time to time; and
 - Declarant is the legal title holder of and wishes to so annex and add to the Condominium Property and therefore submit to the Act as part of the Condominium Property Parking Space (P) Unit P-48 as shown on the Plat attached hereto as Exhibit C and made a part hereof, any Limited Common Elements designated in the Declaration or on the Plat as being

reserved for the use of those Units and Parking Space Units and any other Units and Parking Space Units previously submitted to the Act and all of the Common Elements on the first, second, third, fourth, fifth and sixth floors of the Building as shown on the Plat, to the extent not already submitted to the Act, and all easements, rights and appurtenances belonging thereto, and all fixtures and equipment intended for the mutual use, benefit or enjoyment of the Unit Owners (the "Annexed Property"), as the same may be added to from time to time in accordance with the Declaration. It is acknowledged and agreed that any Proposed Units or Proposed Parking Space Units shown on the Plat, and the seventh floor, are not included in the Condominium Property at this time, but may be added on to the Condominium Property in the future as provided in the Declaration.

Now therefore, Declarant as legal title holder of the Additional Property, and for the purposes above set forth, hereby declares that the Declaration be and hereby is amended as follows:

- 1. The Americal Property is hereby annexed to the Condominium Property as defined in Article 1 of the Peclaration and is hereby submitted to the provisions of the Act as part of the Condominium Property in accordance with and shall be deemed to be governed in all respects by the terms and provisions of the Declaration.
- 2. It is understood that each Unit in the Condominium Property consists of the space enclosed or bound by the horizontal and vertical planes set forth in the delineation thereof in Exhibit C. The legal description of each such Unit shall consist of the identifying number for such Unit as shown in Exhibit C. Exhibit C of the Declaration and the First, Second and Third Amendments are hereby amended and restated in their entirety by Exhibit C attached hereto.
- 3. Exhibit D attached to the Declaration is hereby amended and superseded in its entirety by Exhibit D attached hereto, and respective percentages of ownership in the Common Elements appurtenant to each Unit described in the said Exhibit D prior to this Fourth Amendment are hereby reduced to the respective percentages set forth in Exhibit D, as hereby amended.
- 4. The additional Common Elements are hereby granted and conveyed to the grantees of the Units and Parking Space Units heretofore conveyed, all as set forth in the Declaration.

Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
