## POWER OF ATTORNEY FOR PURCHASE OF REAL ESTATE


POWER OF ATTORNEY made this 14th day of December, 2007.

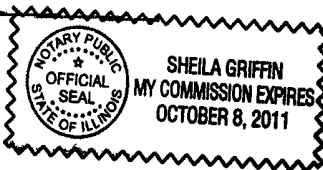
