2. Modified Terms and Conditions. The Security Instrument is modified, amended and supplemented by this Modification, as follows:

Credit Limit Increase: The Credit Limit stated in the Agreement and the Security Instrument is hereby increased by \$85,000.00, from the current amount of \$31,851.00 to the increased amount of \$116,851.00.
