LOAN ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS AGREEMENT made as of the 30 day of November, 2007, by and among 110 CICERO, INC., an Illinois corporation (sometimes, "110"); GEORGE T. HIOTIS (sometimes "George T."), GEORGE A. HR (SIKOS (sometimes, George A."), DIMITRIOS T. HIOTIS (sometimes "Dimitrios T."), and, DEMETRIOS P. HIOTIS (sometimes, "Demetrios P.") WHEREAS, December 23, 2005, 110 borrowed the sum of Four Hundred Thousand and 00/100 Dollars (\$400,000.00) from Lender pursuant to promissory note (the "Note"), a copy of which is attached hereto as Exhibit "A", the proceeds of which were used by 110 pursuant to and in compliance with a Business Loan Agreement dated December 23, 2005 (the "Loan Agreement"), a copy of which is attached hereto as Exhibit "B"; and,

- a.) mortgage (sometimes, the "Mortgage") dated December 23, 2005, executed by 110 in favor of Lender granting Lender a first mortgage encumbering the property commonly known as 11005 South Cicero Avenue, Oak Lawn, Illinois, legally described on Exhibit "C" attached hereto (the "Property");
- December 23, 2005, executed by 110 in favor of Lender encumbering all Leases and Rents at foc Property;
- c.) commercial guarantees (the "Guarantees") dated December 23, 2005, executed by George T., George A., Dimitrios T., and Demetrios P., in favor of Lender guaranteeing payment of the Note.

- 1. The preambles and recitals set forth above are, by this referenced, incorporated into ano made a part of this Agreement.
- 2) Subject to the terms contained herein, Lender consents to the sale, transfer, assignment and conveyance by Assignors to Assignee of all Assignors' respective rights, titles and interests in and to the Property.
- 3) Assignee, without release of Assignors, or any them, hereby expressly assumes all obligations, liabilities, responsibilities and duties to Lender, evidenced by and in connection with the Loan Documents, Assignee acknowledging and agreeing that the liens heretofore granted Lender, including but not limited to those liens granted Lender, encumbering the Property pursuant to the Mortgage and the Assignment of Rents, shall remain valid, and in full force and effect, according to their original tenor.

Lender's consent to the assumption hereby given shall not constitute or operate as a release of Assignors of their obligations to Lender under the Loan Documents, Assignors, and each of them, being and remaining fully liable and responsible for responsible for satisfying and complying with the terms and provisions contained therein.
