The undersigned, The Rockwell Group, Inc., an Illinois Corporation (herein referred to as the "Claimant"), hereby files its Notice and Claim for Lien against LaSalle National Bank, as Trustee under Trust Agreement dated September 8, 1978, known as Trust Number 100012 ("Owner") and Woodfield Bank ("Lessee"); JPMorgan Chase Bank, N.A. ("Tenant"); and National Construction Services, Inc. ("Contractor"), and all other persons claiming to be interested in the premises; and the Claimant states:

1. That on March 22, 2006, the Owner owned and continues to own, the following described premises in the County of Cook, State of Illinois, to-wit:

That part of the West Half of Section 13, Township 41 North, Range 10 East of the Third Principal Meridian, bounded by a line described as follows:

Beginning at the intersection of the West line of Meacham Road (being a line 70.00 feet West of and parallel with the East line of the West Half of the Southwest Quarter of said Section 13), per Document No. 20707159, with the Northeasterly line of Higgins Road as monumented and occupied, per Document No. 12105145; thence North 80 degrees 27 minutes 24 seconds West, along said Northeasterly line of Higgins Road, 431.99 feet; thence North 00 degrees 25 minutes 37 seconds East, parallel with the said West line of Meacham Road, 476.42 feet; thence South 89 degrees 34 minutes 23 seconds East, 426.53 feet to a point in said West line; thence South 00 degrees 25 minutes 37 seconds West, along said West line of Meacham Road, 544.66 feet to the place of beginning in Cook County, Illinois; situated in Cook County in the State of Illinois.

2. National Construction Services, Inc. was the General Contractor for the Tenant for the improvement of the above-described premises.


3. The Claimant entered into a Subcontractor Agreement dated on or about March 28, 2006, with National Construction Services, Inc., to provide carpentry, drywall, acoustical, stud-framing, steel trusses, ceiling insulation and related labor, material and equipment for the improvement of the premises.

4. That there is now due and owing to the Claimant, the sum of \$13,127.10 for which, with interest, the Claimant claims a lien against the above-described property and against any money or other consideration due to National Construction Services, Inc.
