- 3. The Subcontract and extras thereto were entered into by the General Contractor with the knowledge and consent of the Owner and/or Unit Owners, and the work was performed with the knowledge and consent of the Owner and/or Unit Owners.
- 4. Claimant achieved substantial completion and last performed work under the Subcontract on November 30, 2007.
- 6. As of the date hereof, there is due, unpaid, and owing to Claimant, after allowing all credits, the principal sum of \$267,833.39, which principal amount bears interest at the statutory rate of 10% per annum. Claimant claims a lien on the Real Estate (including all land and improvements thereon) in the amount of \$267,833.39, as a portioned among the units and common areas, plus interest, and attorney's fees.
