AMENDMENT TO MEMORANDUM OF **MANAGEMENT** AGREEMENT (the "Amendment to Memorandum") is made and entered into as of this day of March, 2008, by UST PHINE III HOTEL SUBTENANT, L.P., an Illinois limited partnership with a mailing address at c/o The Prime Group, Inc., 321 North Clark Street, Suite 2500, Chicago, Illinois 60610 ('Owner"), and MARRIOTT HOTEL SERVICES, INC., a Delaware corporation, with a mailing address at c/o Marriott International, Inc., 10400 Fernwood Road, Bethesca Maryland 20817 ("Manager").

WITNESSETH

WHEREAS, 208 S. LaSalle, LLC, a Delaware lim.feJ liability company ("Original Owner") and Manager entered into that certain Management Agreement dated May 7, 2007 (the "Original Management Agreement") with respect to the operation of the JW Marriott Hotel Chicago (the "Hotel") on the Site located at 208 S. LaSalle, Chicago, Illinois.

WHEREAS, in connection with the Original Management Agreement, Original Owner and Manager entered into that certain Memorandum of Management Agreement, recorded on June 20, 2007 as Document number 0717122071 in the public records of Cook County, Illinois (the "Memorandum").

WHEREAS, the Original Management Agreement was amended by that certain (a) Amendment to Management Agreement dated as of December 13, 2007 (the "First Amendment"), (b) Second Amendment to Management Agreement dated as of December 17, 2007 (the "Second Amendment"), (c) Third Amendment to Management Agreement dated as of the date hereof (the "Third Amendment"), and (d) Fourth Amendment to Management Agreement dated as of the date hereof (the "Fourth Amendment"; the Original Management Agreement, as amended by the First Amendment, the Second

Amendment, the Third Amendment, and the Fourth Amendment, the "Management Agreement").

WHEREAS, Original Owner has conveyed fee simple title to the entire Site as follows (collectively, the "Conveyances"):

- (a) that certain portion of the Site commonly known as the hotel parcel and legally described on Exhibit A attached hereto (the "Hotel Parcel") was conveyed to UST Prime III Hotel Owner, LP, an Illinois limited partnership (the "Hotel Owner"); and
- (b) that certain portion of the Site commonly known as the office/retail parcel and legelly described on Exhibit B attached hereto (the "Office/Retail Parcel") was conveyed to UST Prime III Office Owner, LP, an Illinois limited partnership (the "Office/Retail Owner").

WHEREAS, in connection with the Conveyances, the following agreements were entered into:

- (a) Hotel Owner leased the Hotel Parcel to 151 W. Adams Master Tenant LLC, an Illinois limited liability company (the "Hotel Master Tenant"), pursuant to that certain Master Lease between Hotel Owner and Hotel Master Tenant (the "Hotel Master Lease"); and
- (b) Master Hotel Tenant subjected the Hotel Parcel to Owner, pursuant to that certain Master Sublease between Inchel Master Tenant and Owner (the "Hotel Master Sublease").

WHEREAS, in connection with the Conveyances, the Hotel Master Lease and the Hotel Master Sublease, Original Owner's rights and obligations on der the Management Agreement were assigned to Owner.

WHEREAS, Landlord and Manager desire to amend the Momorandum to memorialize all of the foregoing and to reflect that (a) the Site is expressly limited to the Hotel Parcel, and (b) the Management Agreement shall not encumber the Office Valuel.

NOW, THEREFORE, for the mutual covenants and considerations herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto intending to be legally bound agree as follows:

- 1. <u>Exhibit A</u> of the Memorandum is deleted in its entirety and replaced with Exhibit A attached hereto.
- 2. Except as specifically set forth herein, this Amendment to Memorandum is not intended to alter or modify in any way the terms and conditions of the Memorandum or the Management Agreement. Terms not specifically defined in this
