MEMORANDUM OF MASTER LEASE AND PASS-THROUGH AGREEMENT (HOTEL)

THIS MEMORANDUM OF MASTER LEASE and PASS-THROUGH AGREEMENT is made as of the SM day of March 2008 (this "Memorandum"), by and between UST PRIME III HOTEL OWNER, L.P., an Illinois limited partnership ("Owner"), and 151 W. ADAMS MASTER TENANT LLC, an Illinois limited liability company ("Tenant") and (i) evidences a lease from the Owner, as lessor to the Tenant, as lessee, pursuant to that certain Master Lease dated of even date herewith (the "Master Lease") relating to the hotel portion of the building located at 151 W. Adams Street, Chicago, Illinois and more particularly described in Exhibit A, attached hereto (the "Property") and (ii) a certain Pass-Through Agreement dated of even date herewith relating to the Historic Tax Credits (as defined therein) which will be generated by the rehabilitation of the Property in accordance with Section 47 of the Internal Revenue Code of 1986, as amended (the "Code"). The Master Lease and Pass-Through Agreement provide for the following:

- 1. <u>Term.</u> The term of the Master Lease is 32 years, which term shall commence and terminate as set forth in the Master Lease.
- 2. <u>Subordination</u>. The Master Lease is subordinate to a construction mortgage dated of even date herewith (the "Construction Mortgage") from the Owner, as mortgager to The Union Labor Life Insurance Company on behalf of Separate Account J (the "Senio: Nortgagee") securing a loan in the principal amount of \$209,100,000 and to a mortgage of even date herewith with the Owner, as mortgagor, and Capri Urban Investors REIT (the "Junior Mortgagee") securing a loan in the principal amount of \$12,500,000...
- 3. <u>Attornment</u>. Under the Master Lease the Tenant has agreed to attorn to the Senior Mortgagee and the Junior Mortgagee in the event the Senior Mortgagee or the Junior Mortgagee or either of their successors or assigns succeed to the Owner's interest in the Property.
- 4. <u>Master Sublease</u>. The Tenant will sublease its interest in the Property to UST Prime III Hotel Subtenant, L.P., an Illinois limited partnership (the "Subtenant") pursuant to that certain 151 W. Adams Master Sublease Agreement of even date hereof.

- Under the Pass-Through Agreement, Owner has irrevocably covenanted and agreed to the pass-through of the Historic Tax Credits to the Tenant and to file the Election (as defined in the Pass-Through Agreement) in favor of the Tenant pursuant to Section 50(d) of the Code, for the tax year ending 2010 and for each other year in which QREs (as defined in the Pass-Through Agreement) are placed in service.
- 6. Master Lease Controls this Memorandum of Master Lease. The purpose of this Memorandum is to give record notice of the Master Lease and the Pass-Through Agreement and the rights created thereby, all of which are hereby confirmed. If and to the extent of any conflict between the Master Lease or the Pass-Through Agreement, on the one hand, and this Memorandum, on the other hand, the provisions of the Master Lease and the Pass-Through Agreement shall control over the provisions of this Memorandum.
