## AGREEMENT TO SUBORDINATE LIEN

WHEREAS, James C Ashley and Lisa K. NOW THEREFORE in consideration for One (1) Dollar, and other good and valuable consideration in hand paid, the receipt of which is hereby acknowledged, MORTGAGEE covenants and agrees that LIEN #1, for and on behalf of the legal holder of NOTE #1 shall be and shall remain subordinate and inferior as a lien against the REAL ESTATE to LIEN #2 for all advances to be made on NOTE #2 and any and all modifications thereto and for all other purposes specified therein.
