
DURABLE POWER OF ATTORNEY



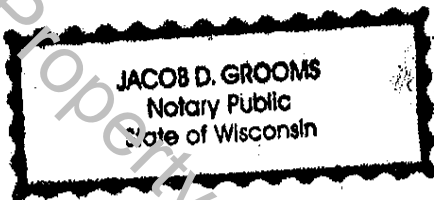
