RELEASE (SATISFACTION) OF JUDGMENTS

On June 21, 2005 Judgment was entered in favor of Plaintiff, HSM Construction Services, Inc. ("HSM"), and against Defendant, HKM Architects + Planners, Inc. ("HKM"), on HSM's claim in the encount of \$17,000.00. Judgment was also entered on the same day in favor of Counter-Plaintiff, HKM, and against Counter-Defendant, HSM, on HKM's counterclaim in the amount of \$42,000.00.

Following appeal, the Appellate Court of Illine's First Judicial District, Sixth Division, on or about April 27, 2007, entered an Order affirming in part and reversing in part the Judgments entered by the trial court. The Appellate Court's Order awarded HSM an additional \$39,121.00 on its claim against HKM. The net effect (the amount awarded on HSM's claim reduced by the amount awarded on HKM's counterclaim) of the Appellate Court's Order and the underlying Judgments entered by the trial court is an award in favor of HSM and against HKM in the amount of \$14,121.00.
