PLEASE TAKE MOTICE that the judgment creditor, CITY OF CHICAGO, through its attorneys, BAKIR, MILLER, MARKOFF & KRASNY, LLC, has registered an administrative judgment with the Circuit Court of Cook County, Illinois, as follows:

On July 11, 2007, an administrative money judgment was rendered in the City of Chicago, Department of Alministrative Hearings ("DAH"), in favor of the plaintiff, CITY OF CHICAGO, and against the Defendant(s), JASON DADE .
