The claimant, Supreme Products Inc of Joliet, Will County, Illinois, hereby files a claim for lien against Kipling Development Corporation, an Illinois Corporation, and Edward Mattox, both of the City of Joliet, Will County, Illinois. On information and belief, prior to September 2, 1998 Kipling Development Corporation and Edward Mattox were the owners of the following-described land in Cook County, Illinois:

PARCEL 1: LOT 30 IN AMBRANCE, BEING A SUBDIVISION OF PART OF THE WEST 1/2 OF SECTION 30, TOWNSHIP 38 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

PARCEL 2: EASEMENT OF INGRESS AND EGRESS OVER OUTLOT A AS DISCLOSED BY DECLARATION OF TRUST RECORDED NOVEMBER 22, 1996 AS DOCUMENT NUMBER 88633270

Prior to August 27, 1998, Kipling Development Corporation made a contract with claimant for and in the improvement of said land, namely the supply and installation of mirrors, shower doors, fireplace logs and fireplace glass doors, as recited by accounts attached hereto as Exhibits A, B, and C. In consideration of said supply and installation, Kipling Development Corporation promised to pay claimant \$8156.25. On September 2, 1998 claimant completed said improvement. Kipling Development Corporation is entitled to NO credits under said contract, leaving unpaid and owing to claimant \$8156.25, for which, with interest, claimant claims a lien on said land and improvements.

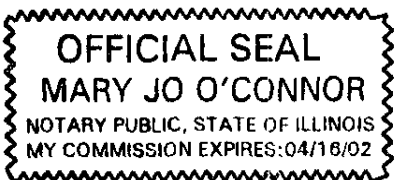
