### LAST WILL AND TESTAMENT LISA ANN HOGLUND

I, Lisa Ann Hoglund of the City of Chicago, Illinois, make this my Will and revoke all prior Wills and Codicils.

#### ARTICLE I

My executor shall pay all expenses of my last illness and funeral, costs of administration including ancillary, costs of safeguarding and delivering bequests, and other proper charges against my estate. My executor shall pay from the residue of my estate all estate and inheritance taxes assessed by reason of my death, except that the amount, if any, by which the estate and inheritance taxes shall be increased as a result of the inclusion of property over which I may have power of appointment shall be paid by the person holding or receiving that property. #### ARTICLE II

My husband's name is George Edward Hoglund, and he is herein referred to as "my nusband".

### ARTICLE III

- A. I give, devise, and bequeath all my estate wherever situated, including all lapsed legacies and devises in which I may have any interest at the time of my death, not otherwise effectively disposed of by this Will or any codicil I might make, to my husband if he survives me by thirty (30) days.

If any of my children do not reach the age of twenty-one (21) years at the time of my death then his or her share under this Article, as the case may be, shall pass to my sister, Sue Doheny, in trust for the benefit of said minor child(ren) upon the following Trust which shall be termed testamentary trust.

#### ARTICLE IV

#### TESTALINTARY TRUST

The Trustee is hereby directed to manage, administer and dispose of the Testamentary Trust in the following manner:

- 1. The Trustee shall pay all the current net income of the Testamentary Trust to Neil and/or Sara as the case may be, while under the age of twenty-one (21) years, the Trustee shall use so much of the income in the Testamentary Trust for said minor child(ren)'s reasonable support, comfort, and education as the Trustee shall determine to be required for those purposes.
- 2. Whenever the Trustee determines that the income of said minor children from all sources known to the Trustee is not sufficient for his or her, as the case may be, reasonable support, comfort and education, the Trustee shall pay to the minor child(ren), or use for his or her benefit, as the case may be, so much of the principal of his or her share in the Testamentary Trust as the Trustee shall determine to be required for those purposes. The Trustee shall be guided generally by a spirit of liberality rather than a policy of frugality, having in mind the beneficiary's age, needs, station in life, and

The principal and income of said fund be so used that the beneficiary receive an education commensurate with his or her, as the case may be, interest, talent and abilities, and to that to which he or she was accustomed at the time of my death.

- 3. When said minor child(ren) have attained the age of twenty-one (21) years, the Trustee shall distribute to the child(ren), as the case may be, the balance of his or her share in the Testamentary Trust.
- 4. Open the death of the minor child(ren) before she, becomes entitled to receive the entire principal of her share in this Testamentary Trust, her share under the Article shall pass to her issue, per stirpes; otherwise, to the survivor of the children, as the case may be.
- 5. If Neil and Sara both predecease me without leaving any descendants surviving them then I give, devise and bequeath the balance of the Testamentary Trust to my heirs at law in accordance with the laws of descent and distribution of the State of Illinois then in force.

#### ARTICLE V

#### POWERS OF TRUSTEE

- A. When any distribution is to be made from the Testamentary Trust, the Trustee shall have discretion, along with Probate Court approval, of determining whether each distribution shall be made in cash, or in kind, or partly in cash, and partly in kind. The judgment of the Trustee, with Probate Court approval, as to value shall be at his or her discretion, and shall be binding upon the respective beneficiaries.
- B. The Trustee shall not be required to give any bond as Trustee.

- C. The Trustee must obtain the order of approval of the appropriate Probate Court in the exercise of any power or discretion herein given.
- D. The Trustee shall have the additional powers with respect to the Testamentary Trust, if any, to be exercised as the Trustee in his or her discretion shall deem to be to the best interest of the beneficieries:
  - 1. to invest and re-invest the Testamentary Trust in any property or undivided interest therein, wherever located, including bonds, notes, secured only; stock of corporations, real estate, or any interest therein acquired after my death; and interest in trust funds.
  - 2. to sell any Testamentary Trust property for cash or on credit, at public or private sale, to exchange any Testamentary Trust property; and to determine the prices and terms of sales, exchanges, and options;
  - to borrow money and to mortgage or pledge any Testamentary Trust property;
  - 4. to take any action with respect to conserving or realizing upon the value of any Testamentary Trust property and with respect to foreclosures, reorganizations, or other changes affecting the Testamentary Trust estate wherever situation, and to execute contracts, notes, conveyances, and other instruments containing covenants and warranties binding upon and creating a charge against the Testamentary Trust estate and containing provisions excluding personal liability;
  - 5. to keep any Testamentary Trust property in the name of a nominee with or without disclosure of fiduciary relationships; and
  - 6. to employ agents, attorneys, auditors, and proxies.
- E. In case of the death, resignation, refusal or inability of my sister to act as Trustee of the Testamentary Trust at any
