MEMORANDUM OF MODIFICATION AGREEMENT Equity Line of Credit, Credit Limit Increase

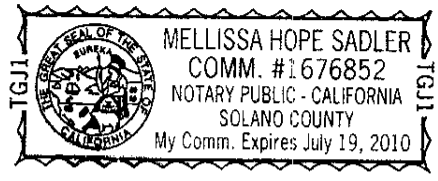



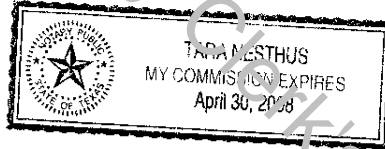
