This Second Amendment to Commercial Mortgage, Assignment of Rents, Security Agreement and Financing Statement ("Second Amendment") is dated as of February 10, 2008, and is made between Nasiruddin M. Daya, individually, whose address is 850 E. Northwest Lighway, Palatine, Illinois 60074 ("Mortgagor") and TCF National Bank, a national banking association ("Mortgagee"), with an office located at 800 Burr Ridge Parkway, Burr Ridge, Illinois 60527.

UNDERSTANDINGS

- 1. The Mortgagor executed a Mortgage in favor of the Mortgagee dated as of <u>January 6, 2006</u> and recorded <u>January 23, 2006</u>, as document number <u>0602304018</u> and First Amendment to <u>Commercial Mortgage</u> dated as of <u>January 29, 2007</u> and recorded on <u>February 26, 2007</u> as document number <u>070570221</u>, in the office of the County Recorder in and for <u>Cook</u> County, <u>Illinois</u> ("Mortgage") encumbering the real est te described on Exhibit A, attached hereto and made a part hereof.
- 2. The Mortgage secures the indebtedness, obligations and liabilities of Mortgagor pursuar, to an amended and restated commercial mortgage installment note dated <u>January 29, 2007</u> in the original principal amount of <u>One Million and 00/100</u> Dollars (\$1,000,000.00), due and payable on <u>February 10, 2012</u> ("Note A") and that certain promissory note dated <u>January 29, 2007</u> in the amount <u>Three Hundred Fifty Thousand and 00/100</u> Dollars (\$350,000.00), due and payable <u>February 10, 2008</u> and a First Note Modification Agreement dated <u>February 20, 2007</u> ("Note B"), payable to Mortgagee and executed jointly and severally by Mortgagor.
- 3. The principal balance of Note A is due and payable on <u>February 10, 2012</u>. As of the date hereof, the outstanding principal balance due is <u>\$958,830.55</u>. The principal balance of Note B is due and payable on <u>February 10, 2008</u>. As of the date hereof, the outstanding principal balance due is <u>\$350,000.00</u>.
- 4. Mortgagor wishes to amend the terms of Note B and the Mortgage, and Mortgagee is willing to do so.

NOW, THEREFORE, in consideration of the Understandings as set forth above and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Mortgagor and the Mortgagee agree as follows:

- B. In all other respects, unless specifically modified hereby, the Mortgage shall remain unchanged and in full force and effect.
