MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated February 8, 2008, is made and executed between BASHIR M. 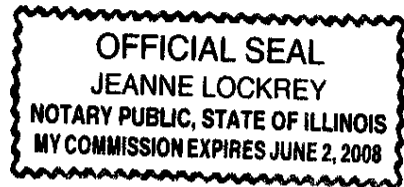

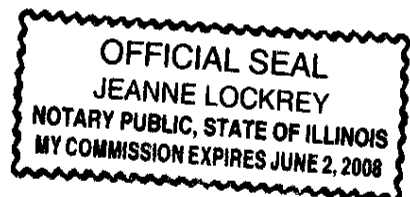
