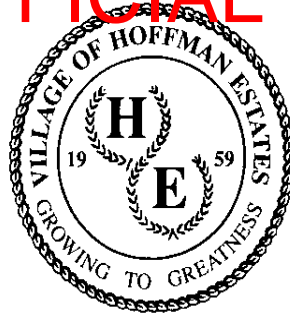

ORDINANCE NO. 3014 - 1998

## AN ORDINANCE EXCLUDING AND DISCONNECTING CERTAIN TERRITORY FROM THE VILLAGE OF HOFFMAN ESTATES

WHEREAS, the following described territory of 2.77 acres lies along the boundary line between the Village of Hoffman Estates and the Village of South Barrington, two adjoining municipalities; and

WHEREAS, the corporate authorities of the Village of Hoffman Estates have determined that the best interests of the Village of Hoffman Estates will be served by the exclusion and disconnection of said territory from the Village of Hoffman Estates and the annexation of said territory to the Village of South Barrington; and

WHEREAS, the corporate authorities of the Village of South Barrington have determined that upon the exclusion of said territory from the Village of Hoffman Estates, the corporate authorities of the Village of South Barrington will adopt an ordinance providing for the annexation of this territory.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Hoffman Estates, Cook and Kane Counties, Illinois, as follows:

Section 1: That the territory of 2.77 lying along the boundary line between the Village of Hoffman Estates and the Village of South Barrington, two adjoining municipalities, which territory is legally described as:

Parcel HE-1: That part of the West ½ of the West ½ of Fractional Section 2 and the East ½ of the East ½ of Fractional Section 3, Township 41 North, Range 9, East of the Third Principal Meridian, lying north of the northerly line of the Illinois State Toll Highway, lying east of a southerly extension of the east line of the west ½ of the southeast ¼ of Section 33, Township 42 North, Range 9, East of the Third Principal Meridian and lying west of the westerly line of Bartlett Road, in Cook County, Illinois.

Parcel HE-2: That part of the South ½ of Section 33, Township 42 North, Range 9, East of the Third Principal Meridian, described as follows: Beginning at the Northeast corner of the south 20.04 chains (1322.64 feet) of the west ½ of the southeast ¼ of said Section 33; thence south 89 degrees 54 minutes 31 seconds west along the north line of the south 20.04 chains of the west ½ of the southeast ¼ of said Section 33, 241.58 feet; thence south 00 degrees 11 minutes 34 seconds east parallel with the east line of the southeast ¼ of said Section 33, 241.58 feet; thence north 89 degrees 54 minutes 31 seconds east parallel with the north line of the south 20.04 chains of the west ½ of the southeast ¼ of said Section 33, 241.58 feet to the east line of the west ½ of the southeast ¼ of said Section 33; thence north 00 degrees 11 minutes 34 seconds west along the east line of the west ½ of the southeast ¼ of said Section 33, 241.58 feet to the point of beginning, in Cook County, Illinois.

be and it is hereby excluded and disconnected from the Village of Hoffman Estates.

Section 2: That the Village Clerk of the Village of Hoffman Estates, upon the adoption of this ordinance and the ordinance annexing the territory hereinabove described to the Village of South Barrington, shall file for recordation in the office of the Recorder of Deeds of Cook County, a certified copy of this ordinance for exclusion, together with a certified copy of the ordinance of annexation as required by law, together with an accurate map of the excluded territory, a Plat of Disconnection, as attached hereto as Exhibit "A".
