RELEASE OF SUBCONTRACTOR'S CLAIM FOR MECHANICS LIEN

That part of Lake Michigan lying east of and adjoining those portions of fractional section 7 and section 18, township 41 north, range 14, east of the third principal meridian, occupied by the campus of Northwestern University and more particularly described as follows: Beginning at a point, being the intersection of the shoreline of Lake Michigan and a line 325 feet south of and parallel to the south line of Lincoln Street, thence east along a line perpendicular to the east line of Sheridan Road to a point 2500 feet east of the east line of Sheridan Road;

thence south along a line 2500 feet east of and parallel to the east line of Sheridan Road; a distance of 3700 feet; thence west along a line perpendicular to the east line of Sheridan Road to the shore line of Lake Michigan; thence northerly along said shore line to the point of beginning, in Cook County, Illinois.

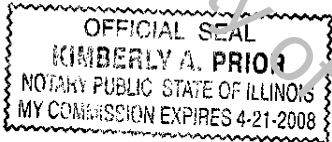
