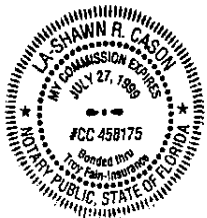

Unless an agreement is made or applicable law requires interest to be paid, Lender shall not be required to pay Borrower any interest or penalties on the Funds. Borrower and Lender may agree in writing, however, that interest shall be paid on the Funds.
