MODIFICATION OF MORTGAGE



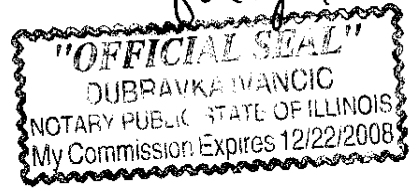

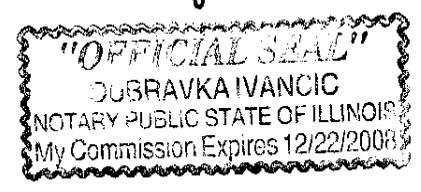
